

**MEDICAL EXPENSE REIMBURSEMENT PLAN OF THE  
CENTRAL VALLEY RETIREE MEDICAL TRUST  
SUMMARY ANNUAL REPORT**

This is a summary of the annual report for Medical Expense Reimbursement Plan (Plan) of the Central Valley Retiree Medical Trust (Employer ID No. 94-2900060, Plan No. 501) for the year ended December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Health insurance premium and expense reimbursement benefits for retired participants, as defined by the Plan document, are provided by contractual contributions from the participants.

**BASIC FINANCIAL STATEMENTS**

The net assets of the Plan at the end of the year totaled \$13,021,312 compared to \$10,122,933 at the beginning of the year. During the year, the Plan experienced an increase in net assets of \$2,898,379. This change includes active participants' contributions and unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of plan assets at the end of the year and the value of assets at the beginning of the year or the cost of assets acquired during the year.

During the year, the Plan had total income of \$3,638,660, of which contributions from the active participants were \$1,078,379, contributions from participating employers were \$513,812, and investment income was \$2,646,469. Deductions from net assets were \$483,669 for benefits paid to participants, \$12,203 for investment advisor fees, and \$244,409 for administrative expenses.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
