

**MEDICAL EXPENSE REIMBURSEMENT PLAN OF THE
CENTRAL VALLEY RETIREE MEDICAL TRUST
SUMMARY ANNUAL REPORT**

This is a summary of the annual report for Medical Expense Reimbursement Plan (Plan) of the Central Valley Retiree Medical Trust (Employer ID No. 94-2900060, Plan No. 501) for the year ended December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Health insurance premium and expense reimbursement benefits for retired participants, as defined by the Plan document, are provided by contractual contributions from the participants.

BASIC FINANCIAL STATEMENTS

The net assets of the Plan at the end of the year totaled \$15,873,519 compared to \$13,021,312 at the beginning of the year. During the year, the Plan experienced an increase in net assets of \$2,852,207. This change includes active participants' contributions and unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of plan assets at the end of the year and the value of assets at the beginning of the year or the cost of assets acquired during the year.

During the year, the Plan had total income of \$3,582,561, of which contributions from the active participants were \$1,302,249, contributions from participating employers were \$508,956, and investment income was \$1,771,356. Deductions from net assets were \$460,670 for benefits paid to participants, \$14,911 for investment advisor fees, and \$254,773 for administrative expenses.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of net assets available for benefits of the plan and accompanying notes, or a statement of changes in net assets available for benefits of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the office of the contract administrator, Benefit Programs Administration, 1200 Wilshire Blvd, Fifth Floor, Los Angeles, CA 90017 and at the U.S. Department of Labor in Washington, D.C. or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
